Summary of November 1, 2021 Umpire Advisory Team Meeting

On November 1, 2021, the Umpire Advisory Team (UAT) held a periodic meeting. UAT members in attendance were Bryan Richter, President, Joe Holonich, Secretary, Damon Williams, Rick Morris, Bill Chatterton, John Calamari and Joann Brickwedde.

The meeting was called to order by Bryan Richter. Topics discussed included:

- Lessons Learned from Fall Season

The first topic discussed was an amalgamation of several umpire camp discussions about C level games. It was noted that C level games work for the circumstances they were intended. If C games were eliminated, there would be a need for fewer umpires. In addition, it was reported that some umpires who express concern with C level games often will turn back high-level games when assigned to the better teams.

Ultimately it was agreed that Softball Umpires of Maryland (SUM) is not responsible for determining what team can enter a tournament. However, if individual umpires want, they can always move to other organizations but there may be less games available.

The UAT also spent consideration time discussing the quality of fields. Perspectives were raised about what could be done to ensure improvements in field conditions especially in heavily used areas. A significant concern with field quality was the liability of the umpire for those situations. Coaches will raise concerns to the umpiring crew about concerns with the field.

Although the site director is ultimately responsible for the field, it is the umpire who can stop the game if the umpire believes the field is unsafe. If the site director decides to continue play even if a coach raises concerns about the field quality, can the umpire stop the game if the umpire believes the field is unsafe? If the umpire does not stop the game and a player is injured in an area where the coach raised a concern can the umpire be held personally liable for that injury?

These are the reasons why umpires worry about the quality of the fields.

- Training

Rick Morris reported that it appeared training again this year would not be held at the Community College of Baltimore County, Catonsville. The Catonsville Athletic Director informed Rick that there would be no indoor games either this winter.

A question was asked that if an umpire took training for a high-school organization, could that be sufficient for SUM. Rick stated that it was too soon to decide that. However, if high-school training could substitute for the SUM training, the umpire should at least attend one or two SUM sessions just to meet SUM umpires.

- Umpire in Chief Protocol

This topic related to whether Umpires in Chiefs (UICs) received any formal training. This was related to a tournament where an umpire felt the UIC was not supportive when some concerns

were raised by coaches. It was recommended that consideration be given to developing a UIC manual. Plus, at least a short training class annually could be held and new UICs could have an apprenticeship with more experienced UICs before they are given independent assignments.

- Other Topics

An additional topic discussed at the meeting was the overlap of members on the UAT and the newly formed SUM Executive Committee (EC). At the initial EC meeting, a discussion was held about the fact that there were three members on both the UAT and EC. It was suggested that at least one of those members could limit participation to just the EC.

The UAT agreed that one of the three overlapping members should leave that UAT. However, it was also noted that having join membership on both was a benefit. Dual participation ensures that members of both groups know what is happening; helps avoid duplication; and provides the UAT a way to report to all umpires on topics of interest discussed at the EC.

John Calamari agreed to leave the UAT.
